

Announcement of an internal grant competition at the Faculty of Law of the Palacký University in Olomouc for the year 2024.

The Dean of the Faculty of Law of the University of Olomouc announces a call for applications for internal PF UP grants for the year 2024 in accordance with Article 3, paragraph 1 of the internal standard [PF UP PF-B-21/13-ÚZ01 "the Constitution of the internal grant competition at the Faculty of Law, Palacký University in Olomouc"](#).

Applications for internal grants for the year 2024 may be submitted to one of the 5 areas of grant support according to Article 2 of the internal standard PF UP PF-B-21/13-ÚZ01.

Applications for internal grants are submitted in paper and electronic form to the Vice-Dean for Science and Research through the Office for Science, Research and Project Support. Electronic applications are to be submitted as an attachment to an email (in .doc; .docx or .pdf format) sent to the address kristyna.ondrackova@upol.cz. Mandatory message subject: "PF 2024 internal grant application".

Applications may be submitted by 16th October 2023, by 2 p.m. Only applications delivered physically and electronically by the given deadline in a complete form which contain all the prescribed requirements will be assessed.

Articles 2 and 3 of the internal standards PF UP PF-B-21/13-ÚZ01 determine the content of applications. The maximum scope of one internal grant application is 10 pages of text, excluding brief biographies of the leading researcher and other members of the research team. CVs are limited to 2 pages per team member. The following formatting requirements apply to the applications and CVs: font Times New Roman, font size min. 11, simple spacing, margins min. 2.5 cm.

By the means this call for grant applications, the dean also establishes a list of supported areas and the financial limits for individual grant support areas as follows:

Area 1 – small basic research projects:

- The maximum amount of remuneration for one researcher: CZK 40,000 (wages before taxation, levies are not included in the project budget)
- Maximum bursary amount for a student team member: CZK 20,000
- **Total maximum amount of funding for one project: CZK 150,000**
- **Total amount allocated to this area: CZK 600,000**

Area 2 – research groups:

- The maximum amount of remuneration for one researcher: CZK 20,000 (wages before taxation, levies are not included in the project budget)
- Maximum bursary amount for a student team member: CZK 15,000
- **Total maximum amount of funding for one project: CZK 100,000**
- **Total amount allocated to this area: CZK 200,000**

Area 3 – international cooperation projects:

- The maximum amount of remuneration for one researcher: CZK 20,000 (wages before taxation, levies are not included in the project budget)
- Maximum bursary amount for a student team member: CZK 15,000
- **Total maximum amount of funding for one project: CZK 150,000**
- **Total amount allocated to this area: CZK 150,000**

Area 5 – concepts of research projects:

- The amount of the researcher's remuneration is not an eligible cost.
- Maximum bursary amount for a student team member: CZK 10,000
- Direct non-investment costs related to the implementation of the internal grant are also supported, e.g. materials, small equipment, software, literature, travel costs, services
- **Total maximum amount of funding for one project: CZK 100,000**
- **Total amount allocated to this area: CZK 100,000**

Area 6 – projects to support qualification skills:

- The amount of the researcher's remuneration is not an eligible cost.
- Maximum total bursary amount for a student team member: CZK 10,000
- Direct non-investment costs related to the implementation of the internal grant are also supported, e.g. materials, small equipment, software, literature, travel costs, services
- **Total maximum amount of funding for one project: CZK 150,000**
- **Total amount allocated to this area: CZK 450,000**
